3. No signage &/or advertising will appear without payment in full and a signed Agreement.
4. Advertising / sponsorship cancellation by **March 31, 2024** - full refund will apply¹.
5. Advertising / sponsorship cancellation from **Apr 1, 2024** - 50% refund will apply¹.
6. Advertising / sponsorship cancellations after **May 1, 2024** - **NO REFUNDS**
