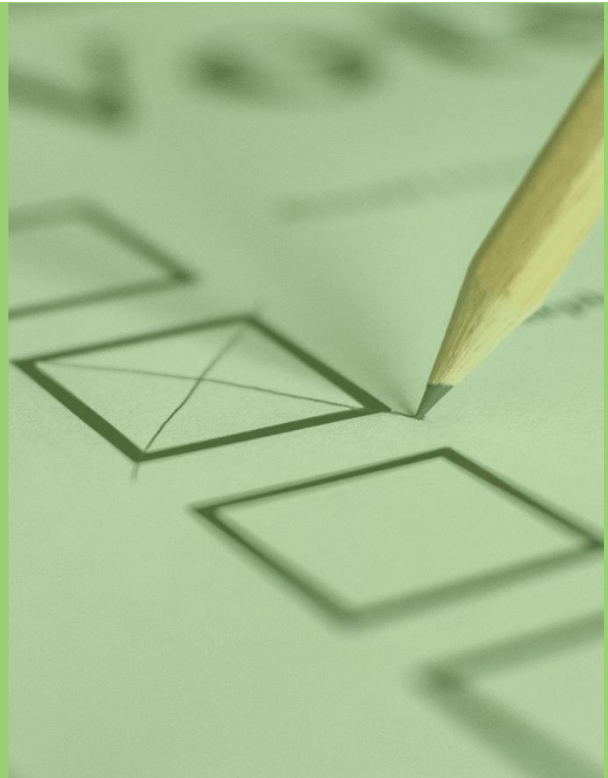

Nomination Period and Nomination Day

The Local Authorities Election Act (LAEA) permits nominations for Mayor and Council to be filed between January 1, 2025 until 12:00 p.m. on September 22, 2025.

“Nomination Day” is the last day that potential candidates may file their nomination papers. In the case of the 2025 general election, September 22, 2025 at 12:00 p.m.

Nomination Papers

Every nomination of a candidate shall be completed through the submission of a Nomination Paper and Candidate’s Acceptance (Form 4). Each nomination paper must be fully completed and include the signatures of at least 5 eligible electors. To ensure the validity of nominations, a candidate may submit more than the required 5 electors’ signatures. If a nomination is not signed by at least 5 electors, the Returning Officer cannot accept the form.

The Town does not collect a deposit to file nomination papers.

Each candidate filing a nomination paper must also submit the Candidate Financial Information (Form 5) at the time of filing. If there is a change to the information that has been submitted on the form, candidates must notify the returning officer within 48 hours of making the change.

Candidates are responsible for ensuring that the nomination papers meet the requirements of the LAEA.

Filing of Nomination Papers

Nominations for the offices of Mayor and Councillor will be accepted by the Returning Officer beginning on January 2, 2025, until **12:00 p.m. on September 22, 2025. Nomination forms are to be filed with Legislative Services by appointment at Town Hall** located at 4905-51 Avenue, Stony Plain.

The Returning Officer is unable to accept nominations before January 1, 2025, or after 12:00 noon on Nomination Day. Facsimiles and electronically submitted copies will not be accepted.

After 12:00 p.m. on Nomination Day, any person may request to examine the filed nomination papers by contacting the Returning Officer to book an appointment.

Withdrawal of Nomination Papers

A person nominated as a candidate may withdraw at any time during the nomination period (January 1, 2025 to 12:00 p.m. on September 22, 2025).

Following the close of nominations at 12:00 p.m. on September 22, 2025, a person may withdraw within 24 hours (12:00 p.m. on September 23, 2025) provided that more than 1 candidate has been nominated for Mayor or that more than 6 candidates have been nominated for Councillors.

The Returning Officer is unable to accept a withdrawal if it would result in less than the required number of candidates for that office.

If a candidate wishes to withdraw their nomination papers, a written notice must be provided to the Returning Officer no later than 12:00 p.m. on September 23, 2025.

Candidates and Official Agents

Throughout the election campaign, the Returning Officer receives requests for candidates' contact information. Requests may come from media, organizers of election forums, or from the general public. In addition, the Deputy Minister of Municipal Affairs requires contact information for candidates.

All candidates and their official agents are encouraged to complete a Release of Candidate Information Form and the Release of Official Agent Information Form and provide it to the Returning Officer with their nomination paper.

The contact information provided by a candidate and official agent will be released upon receiving a request.

If you have concerns about the release of information, please contact the Returning Officer.

Election Signage

Election signs in the Town of Stony Plain are regulated under Land Use Bylaw 2576/LUO/17. The bylaw is currently under review and information will be posted as it becomes available.

Candidates are not permitted to use the Town of Stony Plain logo or seal on any campaign signage or in any campaign advertising. The use of the Town of Stony Plain official logo, election logo and seal on any campaign materials, including signs, brochures, social media or websites, is strictly prohibited.
