SUBJECT: Parkland Turning Points Society

EXECUTIVE SUMMARY

Since 1994, Parkland Turning Points Society has been a place of refuge, healing, and transformation for individuals and families across Stony Plain, Parkland County, Spruce Grove, and the surrounding areas. As a not-for-profit charitable organization, they are deeply rooted in the belief that everyone deserves to live free from violence and fear—and to feel seen, heard, and supported.

BACKGROUND

Parkland Turning Points mission is to break the cycle of family violence and abuse and to restore safety, dignity, and hope through compassionate education and personalized therapeutic support. They offer inclusive, gender-specific group programs that create space for growth, connection and change. They believe real change happens when people feel safe enough to be themselves and supported enough to grow.

The current funding agreement provides operational funding in the amount of \$31,836 for 2025 and \$32,473 (2% increase) in 2026.

EXECUTIVE SUMMARY

Neighbourlink Parkland has been serving Stony Plain, Spruce Grove, and Parkland County since 2000. They are a non-profit charity funded by the support of community, local churches, organizations, and individuals.

BACKGROUND

NeighbourLink Parkland is a Christian Resource Network serving the Greater Parkland Region. Dedicated to addressing the immediate needs of our neighbours with generosity, dignity, and compassion. Through partnerships with community agencies and referral sources, they provide guidance, resources and advocacy to empower and equip vulnerable and marginalized individuals in our community.

The current funding agreement provides operational funding in the amount of \$10,612 for 2025 and \$10,842 (2% increase) in 2026.





SUBJECT: Stony Plain Lions Club

EXECUTIVE SUMMARY

The Stony Plain Lions Club will provide an update to Council on their projects and activities completed in the past year. The Lions have also donated \$160,000 to the Town for the replacement of an ATS bus, placed in service earlier this year.

BACKGROUND

The Stony Plain Lions Club has been serving our community since 1957. Annually, the Stony Plain Lions Club takes on numerous fundraisers, service projects, and community events to enhance the lives of the residents, this presentation will highlight these activities. Many of these projects are done in partnership with the Town of Stony Plain. The Lions club also operates the Lions campground in the North Business Park. The campground lands are leased to the club for the purpose of the campground.

We are excited to announce the Stony Plain Lions Club sponsorship of the Town's replacement ATS bus. The sponsorship amounts to over \$160,000. The Lions Club have been a supporter of the ATS program since its inception and this bus is a lifecycle replacement for a unit that the Lions Club had donated in 2016.
