## Instructions for filing an appeal

Notice of appeal to Stony Plain Subdivision and Development Appeal Board (SDAB) must be filed in accordance with the Municipal Government Act and the Town of Stony Plain Land Use Bylaw.

The notice of appeal form must:

- Be received by the SDAB within 21 days of receipt of written notice or decision from the Development Authority or the Subdivision Authority
- State specific reasons for the appeal
- Be signed by the appellant or their agent
- Be accompanied by the required filing fee payable to Town of Stony Plain
