## **Definitions:**

**Dominant Tenement:** property that uses an easement over another property.

**Easement:** an agreement that gives an individual, company or municipality the right to use a landowner's property in some way. It is the legal right to use or enter onto a part of another property without possessing or owning that property.

**Encroachment:** when a structure or object intrudes onto the property of another without legal right to express permission.

**Real Property Report (RPR):** A legal document prepared by a registered Alberta Land Surveyor that illustrates the location of significant visible improvements relative to property boundaries.

**Servient Tenement:** a piece of land that is subject to an easement, which benefits another piece of land.
