BYLAW 2722/TAX/25

BEING A BYLAW OF THE TOWN OF STONY PLAIN IN THE PROVINCE OF ALBERTA TO AUTHORIZE THE RATES OF TAXATION TO BE LEVIED AGAINST ASSESSED PROPERTY WITHIN THE TOWN OF STONY PLAIN FOR THE 2025 TAXATION YEAR.

WHEREAS, the Town of Stony Plain has prepared and adopted detailed estimates of the municipal revenues and expenditures as required at the Council meeting held on November 25, 2024; and

WHEREAS, the estimated municipal expenditures and transfers set out in the budget for the Town of Stony Plain for 2025 total \$80,063,474; and

WHEREAS, the estimated municipal revenues and transfers from all sources other than taxation is estimated at \$55,895,198 and the balance of \$24,168,276 is broken down between the estimated revenue to be raised by supplementary taxation of \$270,000 and the estimated revenue to be raised by annual taxation of \$23,898,276; and

WHEREAS, the amounts required with respect to requisitions are:

WHEREAS, the Council of the Town of Stony Plain is required each year to levy taxes on the assessed value of all property, including any supplementary assessment prepared under the Supplementary Assessment Bylaw, at tax rates sufficient to meet the estimated expenditures and the requisitions; and

WHEREAS, the Council of the Town of Stony Plain is authorized to sub-classify assessed property and to establish different rates of taxation in respect to each class of property, subject to the *Municipal Government Act*, and amendments thereto; and

WHEREAS, the estimated taxable assessed value of all property in the Town of Stony Plain as shown on the assessment roll is:

NOW THEREFORE, the Council of the Town of Stony Plain, in the Province of Alberta, duly assembled, hereby enacts as follows:

1. That the Chief Administrative Officer is hereby authorized to levy the following rates of taxation for 2025 against the assessed value of all taxable property shown on the assessment roll for the Town of Stony Plain and against the assessed value of property for which a supplementary assessment has been prepared under the Supplementary Assessment Bylaw:
